**1) I need a visa invitation letter only (free of charge)**

German Industry and Commerce (GIC), as the representative office of ASIA FRUIT LOGISTICA, will provide an official invitation letter for each visa applicant to apply a visa to Hong Kong during ASIA FRUIT LOGISTICA only. The invitation letter will be issued free of charge\*

**2) German Industry and Commerce shall handle the application for me (at cost)**

German Industry and Commerce (GIC), as the representative office of ASIA FRUIT LOGISTICA, acts as an agent to handle the application on behalf of the applicant, i.e. apply, trace and collect the visa from the Hong Kong Immigration Department (at cost)

**Service charge:** Handling fee of **HKD 900.00\*\*** per person for registered exhibitor/ visitor ONLY

1. Excluding courier cost for documents (delivery of the application form and supporting documents and delivery of the issued visa)
2. Cost includes the visa fee to the Hong Kong government (around HKD160.00).
3. All service charges are non-refundable even though the visa application is rejected.
