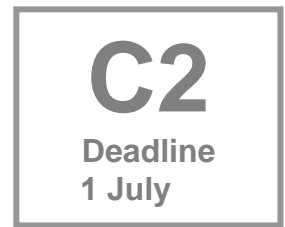

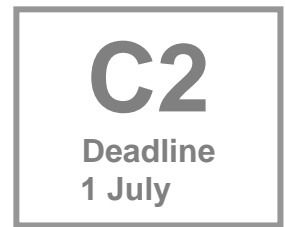

4. In general, a visa application requires 8 weeks of processing time from submission of application to receipt of the visa - please make sure to apply as early as possible.
5. Once the visa application has been submitted, the Immigration Department does not provide information on the application status until the application has been decided, so GIC cannot offer follow-up calls to the Immigration Department.
6. GIC reserves the right to charge administrative charge for re-issuance of Invitation Letter due to any fault from the applicants.
7. GIC may ask the visa applicants to provide certain documents in order to ensure a smooth visa application, the documents will be kept for a certain period, e.g. until the expiry of the visa, and will then be destroyed without further notification.
